





from 12/31/2011 to 03/06/2017



Contribution to consolidated Net Banking Income by activity at 31 December 2016




Breakdown of International NBI by Geography at 31 December 2016








Net Banking Income in billion MAD




() Net Income Group Share / Number of Shares




Customer Deposits in billion MAD




Gross Operating Income in billion MAD








Net Income in billion MAD




NPL Ratio in %
